(7) Documents required:

2. Packing List in **(3)** copies.

3. Full set 3/3 original Bill of Lading made out **TO ORDER / TO ORDER OF OPENING BANK** marked **FREIGHT PREPAID/COLLECT** and notify the **APPLICANT.**

4. Policy / Certificate of Insurance in duplicate for full CIF value plus 10 percent covering Institute Cargo Clauses (A), Institute War Clauses (Cargo), Institute Strikes Clauses (Cargo) and blank endorsed by the assured. (For CIF, DDP & DDU Terms)  
All B/L detailed arrangements will be made subject to the final consent by mills and Tricell.

**(8) Advising Bank Information:**
